# European Solidarity Corps: How to take part as an organisation?



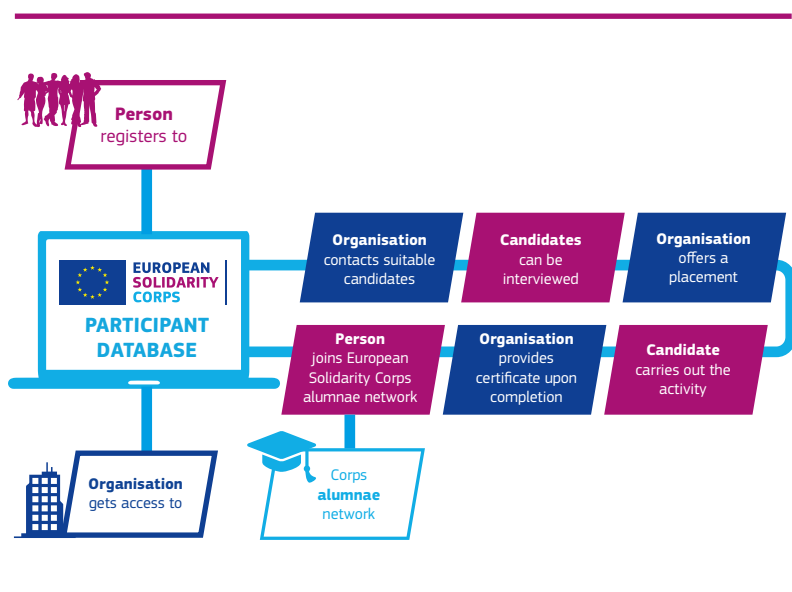
Organisations play a vital role in the European Solidarity Corps. They are those that offer placements to young people registered for the Corps. In this first phase, before the entry into force of the new legal base, organisations willing to participate in the European Solidarity Corps can apply for funding through existing EU funding programmes. Eight programmes support the European Solidarity Corps:

- Erasmus+ Programme with its European Voluntary Service
- EU Programme for Employment and Social Innovation (EaSI)
- LIFE programme
- Europe for Citizens programme
- Asylum, Migration and Integration Fund (AMIF)
- European Regional Development Fund (through the Interreg programme)
- Agricultural Fund for Rural Development
- Health programme



## What organisations can participate?

A large variety of organisations such as non-governmental organisations, civil society organisations, national, regional and local authorities or social enterprises could become a participating organisation. After having been authorised in line with each contributing EU funding programme, the participating organisation can look for potential employees, trainees, apprentices or volunteers for their solidarity activities in the Corps database. In case of the Employment and Social Innovation Programme, an intermediary will be in charge of matching organisations with suitable candidates. Each participating organisation will have to comply with high quality standards, will need to subscribe to the European Solidarity Corps Mission Statement and its Principles, and will have to adhere to the European Solidarity Corps Charter, setting out the rights and responsibilities during all stages of the solidarity experience.
