SADC List of Physical Projects

- ❑ There are 27 projects all together categorized as follows:
 - ❑ Transmission projects at advanced stage of development
 - ❑ Transmission projects at initial stage of development
 - ❑ Transmission projects at concept stage
 - ❑ Generation projects at advanced stage of development
 - ❑ Generation projects at initial stage of development
 - ❑ Generation projects at concept stage

SADC List of Physical Projects

- ❑ Transmission projects selected based on three key objectives:
 - ❑ Connecting non-connected Member States of Angola, Malawi and Tanzania;
 - ❑ Reducing congestion on existing lines; and
 - ❑ Moving power from generation points to demand centres
 - ❑ The list is too long; need to establish where the financing of EDF will be required
 - ❑ The projects need to be screened further

SADC List of Physical Projects

- ❑ Prioritization was done based on the SADC Master Plan and SAPP Pool Plan and the List could be tentatively shortened as follows:
 - ❑ Transmission
 - ❑ ZIZABONA
 - ❑ CTC in Zimbabwe
 - ❑ ZTK Interconnector
 - ❑ Mozambique-Malawi Interconnector
 - ❑ Namibia-Angola
 - ❑ Mozambique Backbone

SADC List of Physical Projects

- ❑ Generation Projects
 - ❑ Mpanda Mkuwa in Mozambique
 - ❑ HCB North
 - ❑ Batoka Hydro Project
 - ❑ Kudu gas project
 - ❑ SADC will hold a workshop with Member States in 2 weeks where the list will be filtered through the criteria presented during this workshop and state of preparedness confirmed with MSs
 - ❑ A shorter list would be easier for EU to efficiently support and engage with relevant MSs

COMESA List of Physical Projects

- ❑ The only project identified for the SA Region is the ZTK also a priority project from EAC and SADC

IOC List of Physical Projects

- ❑ Based on a Programme being financed by EDF 10, There might be need for mapping of potential sources of renewable energy this is more of a soft project

Observations

- ❑ Using the approach of the Transport group, there might be need for have projects which would be ready for the Work Plan for 2015
- ❑ Need to share the indicative list of priority projects with the selected financial institution to have an idea of their needs
- ❑ Some projects are costed and others are not, this needs to be updated after the workshop

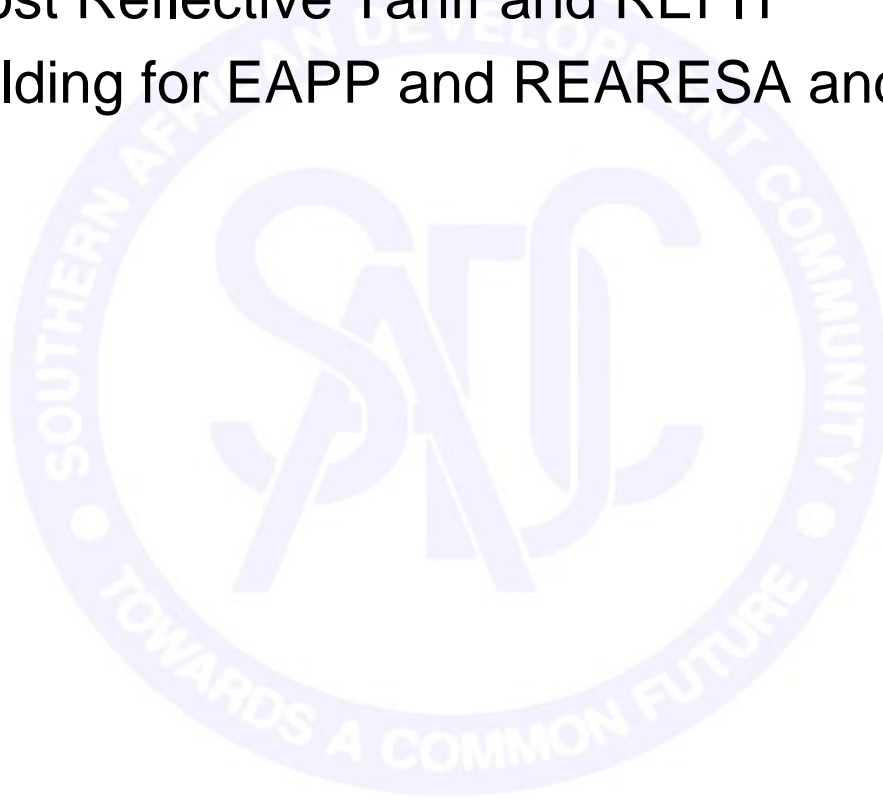
SADC List of Soft Projects

- ❑ Development and review of governance instruments for the energy sector – Protocol and Regional Energy Policy
 - ❑ Capacity building for the SAPP and RERA
 - ❑ Contribution towards the establishment of SACREEE
 - ❑ Contribution towards the project development facility under discussion with the World Bank

COMESA List of Soft Projects

- ❑ Development of Energy Efficiency Framework
- ❑ Electricity Cost Reflective Tariff and REFIT
- ❑ Capacity Building for EAPP and REARESA and their members



Observations

- ❑ Most soft issues are common among the RECS
- ❑ There was a discussion of Twinning where EAC shared their experience and SADC reported that they have no experience in this area for the energy sector apart from exchange programmes, secondments and study visits
- ❑ There is need to cost the soft measures to estimate EDF funds intervention
