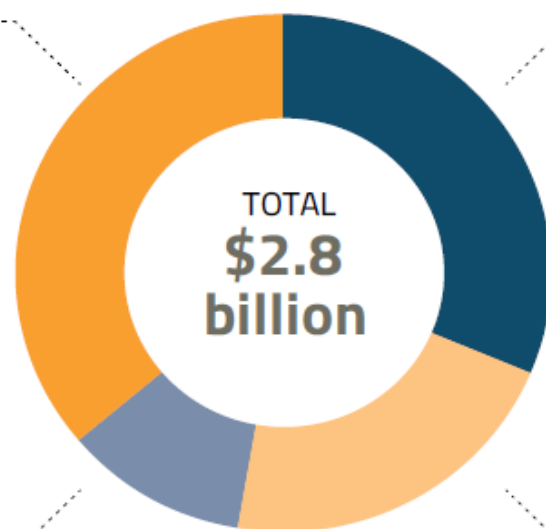

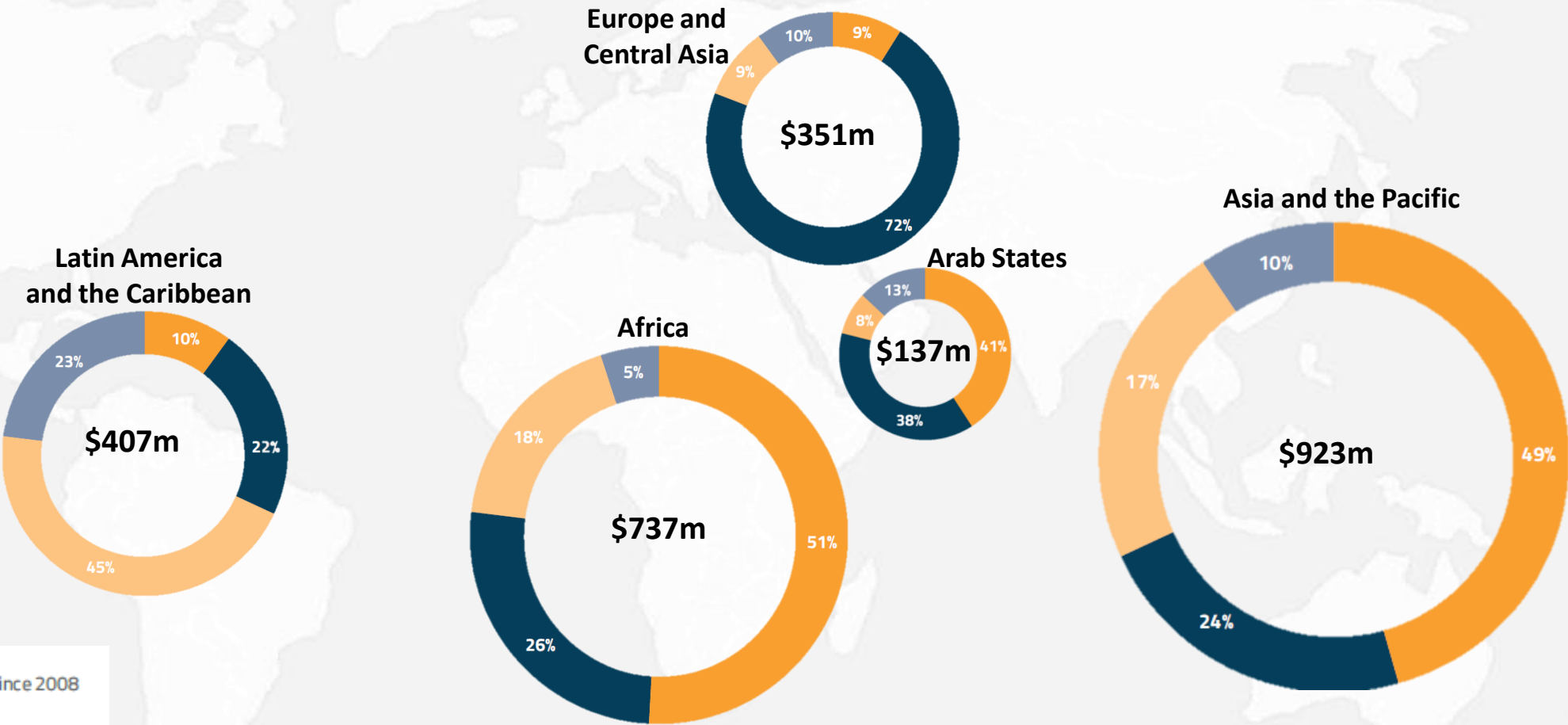

In \$ millions

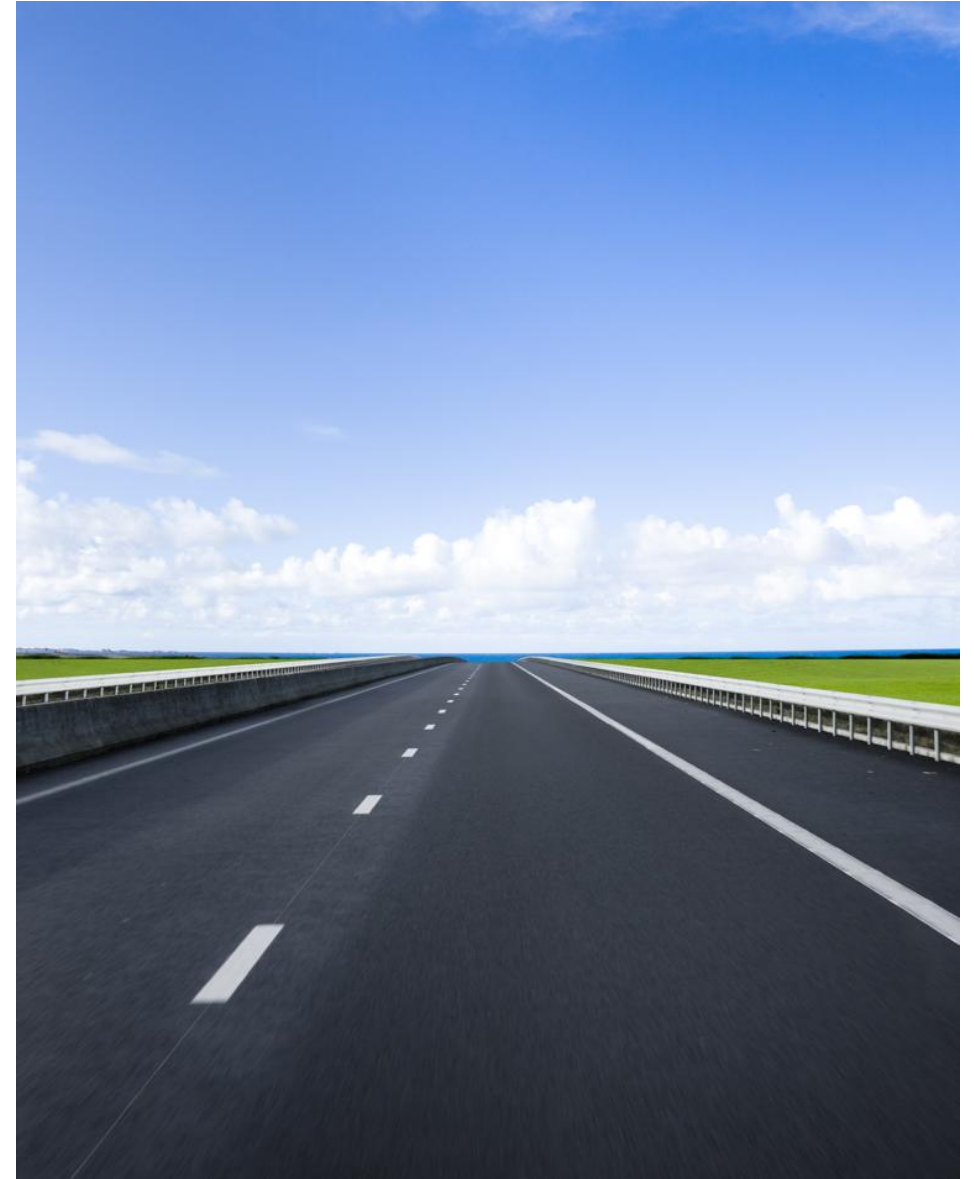

UNDP Support on INDCs and Post-Paris Process

- Leading provider of support to developing countries on INDC preparations through the support of the EU and other donors. Technical and financial support was provided for:
 - Strengthening **negotiation capacities** for COP delegations
 - **Formulation of INDCs** in 43 developing countries, and post-Paris, the **design of NDC implementation plans** in 38 countries.
 - Global workshops and two rounds of **Regional Technical Dialogues hosted by UNDP & partners** to facilitate INDC development, and post-Paris NDC implementation planning. Over 1,000 participants from 130 countries benefited from each round.
 - Development of **INDC and NDC Guidance Document** through participatory approach (feedback through survey, Regional Technical Dialogues, e-discussion etc.)
 - Formulation of tailored **mitigation and adaptation actions, plans and strategies** and strengthens institutional capacities to implement NDCs.

Road to COP 23

- Definition of “**Rules**” for the **Paris Agreement** incl.
 - Access to financial, technical and capacity building support
 - Expectations for monitoring, reporting and verifying activities
- SIDS COP 23 Presidency as an opportunity to highlight the **special circumstances of most vulnerable countries**
- COP 23 to **set the tone for linking national activities under the Paris Agreement with the SDGs, Sendai and Addis**



UNDP Support for COP23 - Negotiations

Negotiations

- **Technical and advisory support** to COP Presidencies, country delegations, regional groups, coalitions, and chairs of negotiating tracks on key issues of the UNFCCC negotiations.
- **Helping delegations design the “rulebook” for the Paris Agreement**, including on NDCs, mitigation, adaptation, transparency, finance, capacity building and forests.

Country-Level

- Support for **Implementation of UNFCCC outcomes** delivering programming under the GCF, GEF, AF and other multilateral and bilateral partners
- Support for **NDCs and mitigation and adaptation action, plans** (NAMAs, NAPs, NAPAs and more).

Highlights: ACP Country Examples of EU-funded
INDC & NDC Implementation Planning Support

Barbados

INDC Submitted	Paris Agreement Signed	Paris Agreement Ratified
September 30, 2015	April 22, 2016	April 22, 2016

- Developing an **NDC Implementation Plan** with key sectors in environment, energy, transport, water, finance
- Held a **national dialogue** to discuss NDC Implementation planning, assessment of Sustainable Development impacts of NDC activities
- Developing a **National MRV System** tracking adaptation, mitigation, climate finance, SD, green economy
- Conducted **sectoral assessments for vulnerability**, and opportunities to integrate adaptation & mitigation actions
- NDC booklet – access to UNFCCC Technology & Finance mechanisms



Sierra Leone

INDC Submitted	Paris Agreement Signed	Paris Agreement Ratified
October 1, 2015	April 22, 2016	November 1, 2016

- National consultations to identify long-term mitigation and adaptation strategies, **National MRV System and NDC Roadmap**
- Reviewing the 2008 Environment Protection Agency Act to incorporate issue of NDC and Climate Change;
- **Proposing 1991 constitution** under revision to include chapter on the Environment, Natural Resources and Climate Change
- **Broad public engagement** campaign through broadcasting, youth and environmental clubs



Nigeria

INDC Submitted	Paris Agreement Signed	Paris Agreement Ratified
November 18, 2015	April 22, 2016	Not Yet

- Preparation and technical assistance for Nigerian COP22 delegation
- Developing **five sectoral action plans** for Agriculture, Industry, Oil & Gas, Energy and Transport (draft action plans done), along with a MRV discussion note.
- Conducted **assessments of sectoral governance environment and policies**
- Will develop 'lighthouse'/**demonstration projects** for each of its five sector action plans to demonstrate impact



Samoa

INDC Submitted	Paris Agreement Signed	Paris Agreement Ratified
November 23, 2015	April 22, 2016	April 22, 2016

- **NDC implementation target** of 100% Renewable Electricity
- Conducted **major consultation with key stakeholders** from the Energy Sector for NDC target and development of RE registry framework
- Substantive **review of policies, regulation and legislation**
- **Launched NDC Roadmap** on National Energy Day - including an Awareness Day celebration & NDC School Awareness Campaign
