Introduction

The Ministry of Forestry is committed to solve problems in forestry sector and to promote forms of good forest governance through process of transparent and accountable good governance. This commitment is proved through initiative of Forest Law Enforcement and Governance (FLEG) Asia in September 2001. This initiative is continued with Forest Law Enforcement Governance and Trade (FLEGT) Action Plan in 2003, where Indonesia had been negotiating partnership agreement with European Union to avoid timber trade and timber production from illegal sources in Indonesia in the European Union market, while simultaneously timber trade and timber production from legal sources were promoted. .

Timber Legality Assurance System (TLAS) is developed as one of initiatives implemented to cope with illegal logging and promote legal wood as SVLK has been established since 2003 through multistakeholders process. This will be a a core of the for the Voluntary Partnership Agreement (VPA) between Indonesia and European Union as it is called *Timber Legality Assurance System (TLAS)*. Under this system, all products covered in this agreement must have legality licenses to enter EU market. The Indonesian Government adopts SVLK as regulation in 2009 and its application starting in September 2010 including Assessment on Performance of Sustainable Production Forest Management ((PK PHPL) and Timber Legality Verification (VLK).

SVLK which is decreed through Minister of Forestry's Regulation (Permenhut) Number No.P.38/Menhut-II/2009 has been revised through Permenhut P.68/Menhut-II/2011 and Permenhut P.45/Menhut-II/2012. Nevertheless, despite SVLK is developed through improvement process and multistakeholders processes which are accepted by all stakeholders, particularly at central level, but the effectiveness of this regulation's socialization to provincial level and district level has raised questions. However, inadequate understanding and weak commitmen from the central government to provincial/distric administration along with other parties to this system will cause risks to effectiveness of SVLK implementation and could ruin Indonesia's TLAS credibility.

Objectives

This event is aimed to strengthen the understanding by multistakeholders of TLAS process and development up to now, especially on its relevance with the implementation in the Riau Province.

Output

Through this event, it is hoped to generate a strengthened understanding by the multistakeholders of TLAS development and its latest updates in both provincial and national levels. And, to ensure smooth implementation of the legality verification.

Methodology

Time & Place

The workshop was held on May 23 2013 and took place at Golden Harvest Hotel, Jambi.

Participants

The attending participants was about 40 people consisting of 11 governmental participants, 16 NGO participants, 10 public participants, 1 media participant, 1 participant from forestry company, and 1 participant from university.

This event was organized by WWF Indonesia in the program of "Advancing a legal and sustainable global timber trade through the EU FLEGT action plan" and collaborated with Sumatera Independent Monitoring Alliance of Jambi branch.

Issues presented and presenters

The first issue was TLAS within Good Forestry Governance framework presented by Industrial Forest Product Utilization Office Region IV of Jambi. The second issue was about Timber Enterprises and Forestry Condition of Jambi Province by Jambi Forestry Office. Then, Process and Latest Development of TLAS and Its Relevance with FLEGT-VPA by MFP. And the last was Independent Monitoring and TLAS in Jambi Province by Sumatera Independent Monitoring Alliance of Jambi branch.

Organizer

The event was organized by WWF Indonesia through the program of **Advancing a legal and sustainable global timber trade through the EU FLEGT action plan** collaborated with Sumatera Independent Monitoring Alliance of Jambi branch.

Key points during SVLK Workshop in Jambi

- Only 49 timber companies actively in Jambi, while raw materials are not sustainable due to something wrong in forestry system, therefore forest should strengthen timber investment.
- Director General Forestry Enterprise Development (Dirjen BUK) issued regulation P.6/VI-BPPHH/2009 jo P.2/VI-BPPHH/2010 on guidelines on performance assessment implementation on sustainable production forest (PHPL) and timber legality verification. Then Director General amended two regulations (Perdirjen No P.06/VI-BPPHH/2009 jo P.2/VI-BPPHH/2010 with Perdirjen No P.8/VI-BPPHH/2011) which caused confusion for independent observers due to no announcement and socialization on the amendment previously. It takes time for monitoring groups to learn new rules of game.
- There is flow on information on SVLK which is not able to get through communities, which is stagnant at certain level, therefore facilitation cannot work well in Jambi. There are not community-engaging CSOs in the province appointed to facilitate communities who have rights forest (hutan hak) and customary forest (hutan adat) for SVLK. In Java this facilitation works.
- It is huge dilemma in Kerinci district where people need to make money from timber industry, but they lack of facilitation of forest timber product utilization, therefore inevitably there are 43 considerably legal forest enterprises.
- There are some shortcomings in SVLK certification rule of law which is rapidly changeable and it seems that the operators are not strict in implementing law obligation.
- SVLK scheme is merely for export-oriented big companies while its mechanism does not work yet for SMEs, who need stakeholders' help to develop them to be active players.
- Active role and breakthrough by multi-stakeholders are needed to stimulate SMEs to be active in SVLK process.
- CSOs are needed to monitor the implementation of SVLK amid shortcomings appear as some points discussed during the drafting are not covered such as Public Information Openness (KIP) Law number 14 year 2008 is not used for legal reference of SVLK rules of law.

- Jambi Police data say in 2012 there are 206 specific crimes occurred where 55 out of them is illegal logging ones, so SVLK is urgently needed to implement.
- There are concerns from NGOs that complaints over alleged breach by management unit is hardly being responded by authority of VPA.
- In Jambi there are 11 management units dealing with SVLK, where 8 have certificates, 2 units are underway to obtain it and 1 unit does not pass.
