## Snapshot of Current WO Portfolio

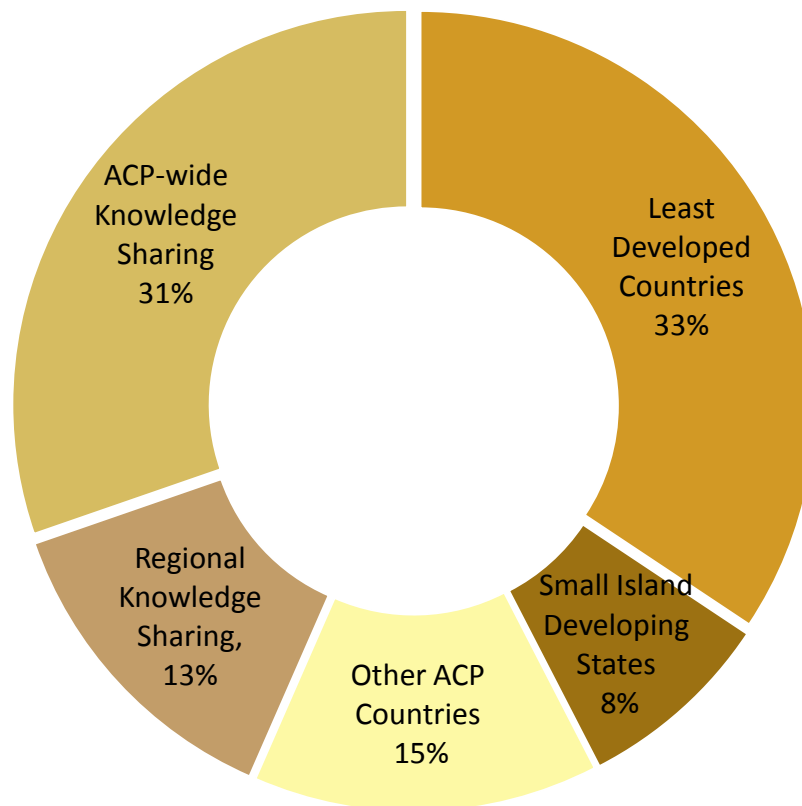
### ❖ Work Order Types

## ❖ Profile of Completed Work Orders

### — Outputs

- Total Planned: 162
- Total Completed: 147

### — Average Cost per Work Order

- Reimbursable: 12,125 Euros
- Expert fees\*: 24,446 Euros

### — Total Expenses of Completed Work Orders

- Reimbursable: 460,740 Euros
- Expert fees\*: 782,264 Euros

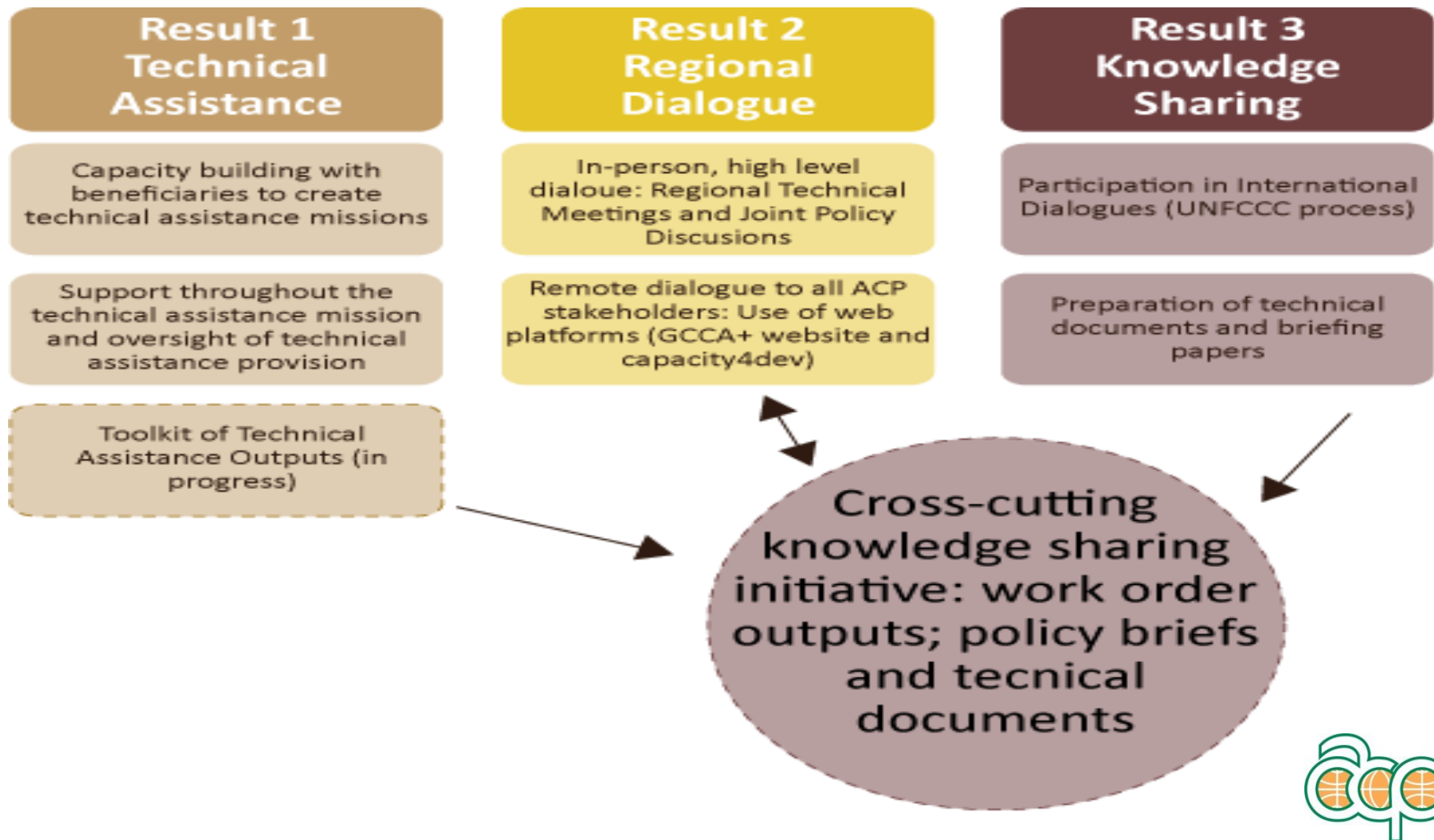

# Knowledge sharing and Communication initiative

## ❖ Knowledge sharing and Communication on platforms:

- Gathered wide range of reports, studies, tools, frameworks, data sources, ...from Regional partners and ACP common position papers, policy papers and outcome statements related to COP
- Categorized into four themes (thematic networking group themes)
- Brief annotation of each document and made available on the relevant platform





# Study Assessing Implementation and Outcomes of Programme

- Overall Programme Implementation – documents, reports, interviews with stakeholders -> good practices, challenges and lessons learnt
- Work Order outputs and outcomes – identify case studies of successful technical assistant missions highlighting lessons learnt -> Knowledge sharing
- Regional components – what worked best, challenges, lessons learnt, achievements, inter and intra regional relationships and with ACP Secretariat
