November RBM&E Forum Update

Communications about the 1st Pan Asia-Africa RBM&E Forum (Bangkok, Nov. 26-28, 2012) have only just begun and considerable interest is being generated. It all seems to be shaping up to be a very stimulating and very worthwhile event.

The Forum is intended to provide RBM&E practioners, consultants, academics, donors, and program managers from a variety of sectors across the Asia-Africa and other regions with a chance to share their views, experiences, and discuss this important development topic.
