Scale of net monthly family income

This scale is used to determine the rate applicable based on the net monthly family income and the number of dependent children.

NB: The contribution for June may be higher, as it includes June and the beginning of July (end of the school year at the European School).

- (d) **Summer holidays:** Changes to enrolment for attendance during the summer holidays will no longer be accepted after the enrolment deadline.

The summer holidays begin on the first working day after the last day of the European School year and end the day before the start of the next school year.
